RESOLUTION NO. 2 3-202 1

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY OF SECURITY SERVICES FOR FY 2021

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Security Services for FY 2021 with an Approved Budget for the Contract (ABC) of Twelve Million Four Hundred Thousand Pesos (Php12,400,000.00), inclusive of all applicable taxes;

WHEREAS, on December 2, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 9, 2020, only one (1) prospective bidder, Commander Security Services, Inc., attended the Pre-bid Conference;

WHEREAS, Commander Security Services, Inc., the lone bidder, participated in the bidding;

WHEREAS, pursuant to Resolution No <u>0.8</u> - 20<u>2.1</u> dated December 21, 2020, the BAC declared Commander Security Services, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Commander Security Services, Inc., found the same to be responsive and thereafter, declared Commander Security Services, Inc., as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Commander Security Services, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Security Services for FY 2021;
- b. recommend the award for the Supply of Security Services for FY 2021 for the Contract Price of TWELVE MILLION THREE HUNDRED SEVENTY-FIVE THOUSAND ONE HUNDRED FORTY-EIGHT PESOS and 80/100 (Php12,375,148.80), inclusive of all applicable taxes; and
- recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
