## **RESOLUTION NO. 106 - 2021**

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF ONE (1) YEAR MAINTENANCE AGREEMENT
RENEWAL OF ENTERPRISE STORAGE SERVER FOR THE BUREAU OF THE
TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Year Maintenance Agreement Renewal of Enterprise Storage Server for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Four Hundred Thousand Pesos (Php4,400,000.00), inclusive of all applicable taxes;

**WHEREAS,** on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 20, 2021, only one (1) prospective bidder, Questech Co., Inc. attended the Pre-bid Conference;

WHEREAS, Questech Co., Inc., submitted its Technical and Financial Bids, which, on December 29, 2021 was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 75 - 2021 dated December 29, 2021, the BAC declared Questech Co., Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Questech Co., Inc. found the same to be responsive and thereafter, declared Questech Co., Inc. as the Single Calculated and Responsive Bidder (SCRB):

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Questech Co., Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Year Maintenance Agreement Renewal of Enterprise Storage Server for the Bureau of the Treasury;
- b. recommend the award for the Procurement of One (1) Year Maintenance Agreement Renewal of Enterprise Storage Server for the Bureau of the



Treasury for the Contract Price of Four Million One Hundred Ninety-Five Thousand Five Hundred Twenty Pesos (Php4,195,520.00), inclusive of all applicable taxes; and

c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
