DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF SUPPORT AND MAINTENANCE SERVICES FOR THE EXISTING DOCUMENT TRACKING SYSTEM OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Support and Maintenance Services for the Existing Document Tracking System of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Pesos (Php2,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 2, 2020, the Invitation to Bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 9, 2020, only one (1) prospective bidder, Valueline Systems & Solutions Corp., attended the Pre-Bidding Conference;

WHEREAS, on December 14, 2020, Supplemental Bid Bulletin No. 13-2020 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 21, 2020, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Procurement of Support and Maintenance Services for the Existing Document Tracking System of the Bureau of the Treasury;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Procurement of Support and Maintenance Services for the Existing Document Tracking System of the Bureau of the Treasury;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
