**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF G-SUITE SOFTWARE LICENSES FOR THE
OFFICIAL EMAIL OF THE BUREAU OF THE TREASURY FOR FY 2021**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of G-Suite Software Licenses for the Official Email of the Bureau of the Treasury for FY 2021 with an Approved Budget for the Contract (ABC) of Two Million Five Hundred Thousand Pesos (Php2,500,000.00), inclusive of all applicable taxes;

WHEREAS, on December 2, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 9, 2020, two (2) prospective bidders, namely, 1) IP Converge Data Services, Inc., and 2) Globe Telecom attended the Pre-bid Conference;

WHEREAS, only one (1) bidder, namely, IP Converge Data Services, Inc., participated in the bidding;

WHEREAS, pursuant to Resolution No 10 - 2021 dated December 21, 2020, the BAC declared IP Converge Data Services, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a wholistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by IP Converge Data Services, Inc., found the same to be responsive and thereafter, declared IP Converge Data Services, Inc., as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare IP Converge Data Services, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of G-Suite Software Licenses for the Official Email of the Bureau of the Treasury for FY 2021;
- b. recommend the award for the Procurement of G-Suite Software Licenses for the Official Email of the Bureau of the Treasury for FY 2021 for the Contract Price of TWO MILLION FOUR HUNDRED NINETY-FIVE THOUSAND ONE PESOS and 60/100 (Php2,495,001.60), inclusive of all applicable taxes; and
