**RESOLUTION NO. 108 - 2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE SUPPLY AND INSTALLATION OF 1 YEAR LICENSE TO EXISTING  
BACKUP SYSTEM OF THE BUREAU OF THE TREASURY**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and installation of 1 Year License to Existing Backup System of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Five Hundred Forty-Eight Thousand Pesos (Php1,548,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 20, 2021, only one (1) prospective bidder, Infobahn Communications, Inc. attended the Pre-bid Conference;

**WHEREAS**, Infobahn Communications, Inc., submitted its Technical and Financial Bids, which, on December 29, 2021 was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 77 - 2021 dated December 29, 2021, the BAC declared Infobahn Communications, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Infobahn Communications, Inc. found the same to be responsive and thereafter, declared Infobahn Communications, Inc. as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Infobahn Communications, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and installation of 1 Year License to Existing Backup System of the Bureau of the Treasury;
- b. recommend the award for the Supply and installation of 1 Year License to Existing Backup System of the Bureau of the Treasury for the Contract Price of

One Million Five Hundred Forty-Five Thousand Nine Hundred Ninety-Nine Pesos and 84/100 (Php1,545,999.84), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
