**RESOLUTION NO. 25-2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE MULTIPROTOCOL LABEL SWITCHING (MPLS) VIRTUAL PRIVATE  
NETWORK (VPN) OR MPLS VPN AND INTERNET SERVICE SUBSCRIPTIONS  
RENEWAL FOR THE BUREAU OF THE TREASURY REGIONAL OFFICES  
(BTR-RO)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Multiprotocol Label Switching (MPLS) Virtual Private Network (VPN) or MPLS VPN and Internet Service Subscriptions Renewal for the Bureau of the Treasury Regional Offices (BTr-RO) with an Approved Budget for the Contract (ABC) of Seven Million Pesos (Php7,000,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 2, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 9, 2020, two (2) prospective bidders, namely, 1) PLDT INC., and 2) Globe Telecom attended the Pre-bid Conference;

**WHEREAS**, PLDT INC., the lone bidder, participated in the bidding;

**WHEREAS**, pursuant to Resolution No 11 - 2021 dated December 21, 2020, the BAC declared PLDT INC., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by PLDT INC., found the same to be responsive and thereafter, declared PLDT INC., as the Single Calculated and Responsive Bidder (SCRB);


**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare PLDT INC., as the Single Calculated and Responsive Bidder (SCRB) for the Multiprotocol Label Switching (MPLS) Virtual Private Network (VPN) or MPLS VPN and Internet Service Subscriptions Renewal for the Bureau of the Treasury Regional Offices (BTr-RO);
- b. recommend the award for the Multiprotocol Label Switching (MPLS) Virtual Private Network (VPN) or MPLS VPN and Internet Service Subscriptions Renewal for the Bureau of the Treasury Regional Offices (BTr-RO) for the


Contract Price of SEVEN MILLION PESOS (Php7,000,000.00), inclusive of all applicable taxes; and
