RESOLUTION NO. 109 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND INSTALLATION OF 1 YEAR LICENSES TO EXISTING
VARIOUS SECURITY AND LOAD BALANCING EQUIPMENT OF THE BUREAU
OF THE TREASURY'S ONLINE RESOURCES**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and installation of 1 Year Licenses to Existing Various Security and Load Balancing Equipment of the Bureau of the Treasury's Online Resources with an Approved Budget for the Contract (ABC) of Three Million Seven Hundred Seventy Thousand Pesos (Php3,770,000.00), inclusive of all applicable taxes;

WHEREAS, on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 20, 2021, only one (1) prospective bidder, Secur Links Network and Technologies, Inc. attended the Pre-bid Conference;

WHEREAS, Secur Links Network and Technologies, Inc., submitted its Technical and Financial Bids, which, on December 29, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 78 - 2021 dated December 29, 2021, the BAC declared Secur Links Network and Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Secur Links Network and Technologies, Inc. found the same to be responsive and thereafter, declared Secur Links Network and Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Secur Links Network and Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and installation of 1 Year Licenses to Existing Various Security and Load Balancing Equipment of the Bureau of the Treasury's Online Resources;

- b. recommend the award for the Supply and installation of 1 Year Licenses to Existing Various Security and Load Balancing Equipment of the Bureau of the Treasury's Online Resources for the Contract Price of Three Million Seven Hundred Seventy Thousand Pesos (Php3,770,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
