## **RESOLUTION NO. 72 - 2022**

## DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE PROCUREMENT OF SOFTWARE DEFINED – WIDE AREA NETWORK (SD-WAN) FOR THE PROVINCIAL OFFICES OF THE BUREAU OF THE TREASURY / ITB-6-2023-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Software Defined – Wide Area Network (SD-WAN) for the Provincial Offices of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Eleven Million Pesos (PHP11,000,000.00), inclusive of all applicable taxes;

WHEREAS, on November 24, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 2, 2022, five (5) prospective bidders, namely, 1) Universal Access and Systems Solutions Phil. Inc., 2) Infobahn Communications, Inc., 3) PLDT Inc., 4) Eastern Telecommunications Philippines, Inc. and 5) Pronet Systems Integrated Network Solution Inc attended the Pre-bid Conference;

WHEREAS, pursuant to Resolution No. 53 - 2022 dated December 14, 2022, the BAC declared Infobahn Communications, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Infobahn Communications, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

 a. declare Infobahn Communications, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Software Defined – Wide Area Network (SD-WAN) for the Provincial Offices of the Bureau of the Treasury;

- b. recommend the award for the Procurement of Software Defined Wide Area Network (SD-WAN) for the Provincial Offices of the Bureau of the Treasury for the Contract Price of Nine Million One Hundred Twenty-Two Thousand One Hundred Seventeen Pesos (PHP9,122,117.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
