RESOLUTION NO. 26-2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF THE RENEWAL OF THE ONE (1) YEAR
MAINTENANCE AGREEMENT OF THE ENTERPRISE STORAGE SERVER OF
THE BUREAU OF THE TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of the Renewal of the One (1) Year Maintenance Agreement of the Enterprise Storage Server of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Five Hundred Thousand Pesos (Php4,500,000.00), inclusive of all applicable taxes;

WHEREAS, on December 4, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 11, 2020, only one (1) prospective bidder, QUESTECH CO, INC., attended the Pre-bid Conference;

WHEREAS, QUESTECH CO, INC., the lone bidder, participated in the bidding;

WHEREAS, pursuant to Resolution No 14 - 2021 dated December 23, 2020, the BAC declared QUESTECH CO, INC as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by QUESTECH CO, INC., found the same to be responsive and thereafter, declared QUESTECH CO, INC., as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:


- a. declare QUESTECH CO, INC., as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of the Renewal of the One (1) Year Maintenance Agreement of the Enterprise Storage Server of the Bureau of the Treasury;


- b. recommend the award for the Procurement of the Renewal of the One (1) Year Maintenance Agreement of the Enterprise Storage Server of the Bureau of the Treasury for the Contract Price of FOUR MILLION TWO HUNDRED NINETY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php4,297,500.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.


