RESOLUTION NO. 73 - 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE BUREAU OF THE TREASURY CENTRAL OFFICE / ITB-7-2023-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office with an Approved Budget for the Contract (ABC) of Two Million Five Hundred Thousand Pesos (PHP2,500,000.00), inclusive of all applicable taxes;

WHEREAS, on November 24, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 2, 2022, two (2) prospective bidders, namely, 1) Marquay Trading OPC and 2) Nissan Commonwealth, Inc. attended the Pre-bid Conference;

WHEREAS, pursuant to Resolution No. 54 - 2022 dated December 14, 2022, the BAC declared Nissan Commonwealth, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Nissan Commonwealth, Inc. found the same to be responsive and thereafter, declared Nissan Commonwealth, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Nissan Commonwealth, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office;
- b. recommend the award for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office for the Contract Price of Two Million
