## **RESOLUTION NO. 111 - 2021**

## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE ONE (1) YEAR PREVENTIVE MAINTENANCE OF THE TEN (10) UNITS 20TR AIR HANDLING UNIT (AHU) SERVICING OFFICES OF THE BUREAU OF THE TREASURY LOCATED AT THE PALACIO DEL GOBERNADOR FOR FY 2022

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the One (1) year Preventive Maintenance of the Ten (10) units 20TR Air Handling Unit (AHU) Servicing Offices of the Bureau of the Treasury Located at the Palacio del Gobernador for FY 2022 with an Approved Budget for the Contract (ABC) of Two Million One Hundred Sixty Thousand Pesos (Php2,160,000.00), inclusive of all applicable taxes;

**WHEREAS,** on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 20, 2021, three (3) prospective bidders, (1) Renphil Trading, (2) Sun Valley MPC, and (3) Rose Air Enterprise, Inc., attended the Pre-bid Conference;

**WHEREAS,** Renphil Trading submitted its Technical and Financial Bids, which, on December 29, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 80 - 2021 dated December 29, 2021, the BAC declared Renphil Trading as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading found the same to be responsive and thereafter, declared Renphil Trading as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

 a. declare Renphil Trading as the Single Calculated and Responsive Bidder (SCRB) for the One (1) year Preventive Maintenance of the Ten (10) units 20TR Air Handling Unit (AHU) Servicing Offices of the Bureau of the Treasury Located at the Palacio del Gobernador for FY 2022;
