RESOLUTION NO. 76 - 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND INSTALLATION OF ENTERPRISE STORAGE
SERVER FOR THE BUREAU OF THE TREASURY / ITB-8-2023-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of Enterprise Storage Server for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of **Nineteen Million Seven Hundred Eighty Thousand Pesos (PHP19,780,000.00)**, inclusive of all applicable taxes;

WHEREAS, on November 24, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 2, 2022, six (6) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) Universal Access and Systems Solutions Phil Inc., 3) Altair I Solutions, Inc., 4) Questech Co. Inc., 5) Trends and Technologies, Inc. and 6) Global Sapphire Filipinas, Inc. attended the Pre-bid Conference;

WHEREAS, on December 14, 2022, Integrated Computer Systems, Inc. and Altair I Solutions, Inc. submitted their Technical and Financial Bids, but only the bid of Integrated Computer Systems, Inc. was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 61 - 2022 dated December 20, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Installation of Enterprise Storage Server for the Bureau of the Treasury;

- b. recommend the award for the Supply and Installation of Enterprise Storage Server for the Bureau of the Treasury for the Contract Price of Nineteen Million Seven Hundred Forty-Seven Thousand Five Hundred Seventy-Nine Pesos (PHP19,747,579.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
