**RESOLUTION NO. 113 - 2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE PROCUREMENT OF GEOGRAPHIC INFORMATION SYSTEM (GIS)  
SOFTWARE LICENSE AND SUPPORT FOR THE IMPLEMENTATION OF THE  
NATIONAL ASSET REGISTRY SYSTEM (NARS) FOR THE BUREAU OF THE  
TREASURY (BTR)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Geographic Information System (GIS) Software License and Support for the Implementation of the National Asset Registry System (NARS) for the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Four Million Six Hundred Thousand Pesos (Php4,600,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 14, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 21, 2021, three (3) prospective bidders, namely, 1) Geodata Systems Technologies, Inc., 2) SPIDC and 3) Supermaps Software's Company Limited attended the Pre-bid Conference;

**WHEREAS**, Geodata Systems Technologies, Inc., submitted its Technical and Financial Bids, which, on December 31, 2021 was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 83 - 2021 dated December 31, 2021, the BAC declared Geodata Systems Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Geodata Systems Technologies, Inc. found the same to be responsive and thereafter, declared Geodata Systems Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Geodata Systems Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Geographic Information System (GIS) Software License and Support for the Implementation of the National Asset Registry System (NARS) for the Bureau of the Treasury (BTr);

- b. recommend the award for the Procurement of Geographic Information System (GIS) Software License and Support for the Implementation of the National Asset Registry System (NARS) for the Bureau of the Treasury (BTr) for the Contract Price of Four Million Five Hundred Twenty Thousand Ninety Pesos (Php4,520,090.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
