DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, DELIVERY, AND INSTALLATION OF SERVERS AND STORAGE FOR THE DIGITIZATION SYSTEM OF THE BUREAU OF THE TREASURY / ITB-9-2023-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, and Installation of Servers and Storage for the Digitization System of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Eleven Million Six Hundred Thirty-One Thousand Pesos (PHP11,631,000.00), inclusive of all applicable taxes;

WHEREAS, on November 24, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 2, 2022, four (4) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) Universal Access and Systems Solutions Phil Inc., 3) Trends and Technologies, Inc. and 4) Global Sapphire Filipinas, Inc. attended the Pre-bid Conference;

WHEREAS, pursuant to Resolution No. 62 - 2022 dated December 20, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Delivery, and Installation of Servers and Storage for the Digitization System of the Bureau of the Treasury;
- b. recommend the award for the Supply, Delivery, and Installation of Servers and Storage for the Digitization System of the Bureau of the Treasury for the
