## **RESOLUTION NO. 114 - 2021**

## DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND DELIVERY OF OFFICE CHAIRS FOR THE BUREAU OF THE TREASURY (BTR) CENTRAL OFFICE

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Office Chairs for the Bureau of the Treasury (BTr) Central Office with an Approved Budget for the Contract (ABC) of Four Million Five Hundred Thousand Pesos (Php4,500,000.00), inclusive of all applicable taxes;

**WHEREAS,** on December 14, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 21, 2021, nine (9) prospective bidders, namely, 1) ACMI Office Systems, 2) Igo Digital, 3) Asahi Design Centre, Inc., 4) Lee Designs, 5) LBPI Design International, Inc., 6) Progress Home and Office Furnishings, 7) Design Excellence Home and Office System Co., 8) Coach Concepts, and 9) Magic 24 Marketing attended the Pre-bid Conference;

WHEREAS, five (5) bidders, namely, 1) Coach Concepts, 2) Design Excellence Home and Office System Co., 3) Lee Designs, 4) Progress Home and Office Furnishings and 5) Asahi Design Centre, Inc., submitted their Technical and Financial Bids which, on December 31, 2021 was opened, read, and calculated;


WHEREAS, pursuant to Resolution No. 84 - 2021 dated December 31, 2021, the BAC declared Asahi Design Centre, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Asahi Design Centre, Inc. found the same to be responsive and thereafter, declared Asahi Design Centre, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare Asahi Design Centre, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of Office Chairs for the Bureau of the Treasury (BTr) Central Office;





- recommend the award for the Supply and Delivery of Office Chairs for the Bureau of the Treasury (BTr) Central Office for the Contract Price of Two Million Seven Hundred Sixty-Five Thousand Pesos (Php2,765,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
