**RESOLUTION NO. 78 - 2022**

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)  
FOR THE PROCUREMENT OF 1 YEAR MAINTENANCE AGREEMENT RENEWAL  
FOR CORE SWITCH AND HYPER CONVERGED SERVER OF THE BUREAU OF  
THE TREASURY / ITB-10-2023-G (EPA)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of 1 Year Maintenance Agreement Renewal for Core Switch and Hyper Converged Server of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of **Two Million Four Hundred Eighty-Four Thousand Pesos (Php2,484,000.00)**, inclusive of all applicable taxes;

**WHEREAS**, on November 25, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 5, 2022, only one (1) prospective bidder, Integrated Computer Systems, Inc. attended the Pre-bid Conference;

**WHEREAS**, pursuant to Resolution No. 55 - 2022 dated December 19, 2022, the BAC declared Questech Co. Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Questech Co. Inc. found the same to be responsive and thereafter, declared Questech Co. Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Questech Co. Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of 1 Year Maintenance Agreement Renewal for Core Switch and Hyper Converged Server of the Bureau of the Treasury;
- b. recommend the award for the Procurement of 1 Year Maintenance Agreement Renewal for Core Switch and Hyper Converged Server of the Bureau of the Treasury for the Contract Price of **Two Million Three Hundred Forty-Nine Thousand Pesos (PHP2,349,000.00)**, inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
