RESOLUTION NO.3 0 -202 1

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF VARIOUS ICT EQUIPMENT TO SUPPORT THE NATIONAL ASSET REGISTRY SYSTEM (NARS) OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, Installation and Commissioning of various ICT equipment to support the National Asset Registry System (NARS) of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Eight Million Five Hundred Thousand Pesos (Php8,500,000.00), inclusive of all applicable taxes;

WHEREAS, on December 4, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 11, 2020, only one (1) prospective bidder, Integrated Computer Systems, Inc. attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc., the lone bidder, participated in the bidding;

WHEREAS, pursuant to Resolution No 18 - 2021 dated December 23, 2020, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc., found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Delivery, Installation and Commissioning of various ICT equipment to support the National Asset Registry System (NARS) of the Bureau of the Treasury;
- b. recommend the award for the Supply, Delivery, Installation and Commissioning of various ICT equipment to support the National Asset Registry System



(NARS) of the Bureau of the Treasury for the Contract Price of SEVEN MILLION EIGHT HUNDRED EIGHTY-NINE THOUSAND TWO HUNDRED SIXTY-SEVEN PESOS (Php7,889,267.00), inclusive of all applicable taxes; and

c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
