RESOLUTION NO. 79 - 2022

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND DELIVERY OF VARIOUS PRINTERS FOR THE BUREAU
OF THE TREASURY / ITB-11-2023-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various Printers for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of **One Million Five Hundred Eighty-Five Thousand Six Hundred Pesos (PHP1,585,600.00)**, inclusive of all applicable taxes;

WHEREAS, on November 25, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WWHEREAS, on December 5, 2022, four (4) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) Faxcable, Inc., 3) Link Network Solutions, Inc. and 4) Pronet Systems Integrated Network Solution, Inc. attended the Pre-bid Conference;

WHEREAS, Quartz Business Products Corporation and Integrated Computer Systems, Inc., submitted their Technical and Financial Bids on December 19, 2022;

WHEREAS, pursuant to Resolution No. 56 - 2022 dated December 19, 2022, the BAC declared Quartz Business Products Corporation as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Quartz Business Products Corporation found the same to be responsive and thereafter, declared Quartz Business Products Corporation as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Quartz Business Products Corporation as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of Various Printers for the Bureau of the Treasury;
- b. recommend the award for the Supply and Delivery of Various Printers for the Bureau of the Treasury for the Contract Price of One Million Four Hundred



Ninety-Five Thousand One Hundred Eighty Pesos (Php1,495,180.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
