RESOLUTION NO. 115 - 2021

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT OF LAPTOP NOTEBOOKS
FOR THE BUREAU OF THE TREASURY (BTR)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of Laptop Notebooks for the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Three Million One Hundred Thousand Pesos (Php3,100,000.00), inclusive of all applicable taxes;

WHEREAS, on December 14, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 21, 2021, three (3) prospective bidders, namely, 1) Quartz Business Products Corporation, 2) Integrated Computer Systems, Inc. and 3) Accent Micro Technologies, Inc., attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc. and Advance Solutions, Inc., submitted their Technical and Financial Bids on December 31, 2021;

WHEREAS, pursuant to Resolution No. 86 - 2021 dated December 31, 2021, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of One (1) Lot of Laptop Notebooks for the Bureau of the Treasury (BTr);
- b. recommend the award for the Supply and Delivery of One (1) Lot of Laptop Notebooks for the Bureau of the Treasury (BTr) for the Contract Price of Two

Million Three Hundred Seventeen Thousand One Hundred Fifty Seven Pesos (Php2,317,157.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
