RESOLUTION NO. 80 - 2022

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND DELIVERY OF ALL-IN-ONE DESKTOP COMPUTERS FOR THE BUREAU OF THE TREASURY/ ITB-12-2023-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of All-in-One Desktop Computers for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Twenty-Eight Million Two Hundred Seventy-Five Thousand Pesos (PHP28,275,000.00), inclusive of all applicable taxes;

WHEREAS, on November 25, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 5, 2022, five (5) prospective bidders, namely, 1) Joneco Tech Marketing Corporation, 2) Unison Computer Systems, Inc., 3) Universal Access and Systems Solutions Phil, Inc., 4) Integrated Computer Systems, Inc. and 5) PRONET Systems Integrated Network Solution, Inc. attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc. and Joneco Tech Marketing Corporation submitted their Technical and Financial Bids on December 19, 2022;

WHEREAS, pursuant to Resolution No. 52 - 2022 dated December 19, 2022, the BAC declared Joneco Tech Marketing Corporation as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Joneco Tech Marketing Corporation found the same to be responsive and thereafter, declared Joneco Tech Marketing Corporation as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

 a. declare Joneco Tech Marketing Corporation as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of All-in-One Desktop Computers for the Bureau of the Treasury;



- b. recommend the award for the Supply and Delivery of All-in-One Desktop Computers for the Bureau of the Treasury for the Contract Price of Twenty-Two Million Seven Hundred Fifty-Four Thousand Eight Hundred Seventy-Five Pesos (Php22,754,875.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
