DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE COMPREHENSIVE PREVENTIVE MAINTENANCE FOR THE AUDIO
VISUAL SYSTEM AT THE CAFETERIA, MARBLE HALL, AND SERGIO OSMEÑA
LECTURE THEATER OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Comprehensive Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, and Sergio Osmeña Lecture Theater of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Eight Hundred Thousand Pesos (Php2,800,000.00), inclusive of all applicable taxes;

WHEREAS, on December 8, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 15, 2020, two (2) prospective bidders, namely, (1) JMS Technology and Supplies and (2) AVLS All Visual & Lights Systems Corporation attended the Pre-bid Conference;

**WHEREAS**, AVLS All Visual & Lights Systems Corporation, the lone bidder, participated in the bidding;

WHEREAS, pursuant to Resolution No 20 - 2021 dated December 26, 2020, the BAC declared AVLS All Visual & Lights Systems Corporation as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by AVLS All Visual & Lights Systems Corporation, found the same to be responsive and thereafter, declared AVLS All Visual & Lights Systems Corporation as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE,** the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare AVLS All Visual & Lights Systems Corporation, as the Single Calculated and Responsive Bidder (SCRB) for the Comprehensive Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, and Sergio Osmeña Lecture Theater of the Bureau of the Treasury;



- b. recommend the award for the Comprehensive Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, and Sergio Osmeña Lecture Theater of the Bureau of the Treasury for the Contract Price of TWO MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (Php2,750,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
