## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT HIGH END DESKTOP COMPUTERS TO THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot High End Desktop Computers to the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00), inclusive of all applicable taxes;

WHEREAS, on December 3, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 10, 2020, three (3) prospective bidders, namely, 1) DCI International I.T. Solution and Services Corp., 2) Masangkay Computer Center, and 3) Quartz Business Products Corporation attended the Pre-bid Conference;

WHEREAS, Advance Solutions Inc., the lone bidder, participated in the bidding:

**WHEREAS**, pursuant to Resolution No 12 - 2021 dated December 22, 2020, the BAC declared Advance Solutions Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Advance Solutions Inc., found the same to be responsive and thereafter, declared Advance Solutions Inc., as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE,** the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Advance Solutions Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of One (1) Lot High End Desktop Computers to the Bureau of the Treasury;
- b. recommend the award for the Supply and Delivery of One (1) Lot High End Desktop Computers to the Bureau of the Treasury for the Contract Price of ONE MILLION THREE HUNDRED NINE THOUSAND PESOS (Php1,309,000.00), inclusive of all applicable taxes; and



c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
