RESOLUTION NO. 82 - 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY OF SERVICE FOR THE OPERATION & PREVENTIVE MAINTENANCE OF THE MECHANICAL, ELECTRICAL, PLUMBING AND FIRE PROTECTION (MEPF) SYSTEMS OF THE AYUNTAMIENTO BUILDING , AND AIR HANDLING UNITS, COOLING TOWERS AND POWER DISTRIBUTION SYSTEMS OF BTr OFFICES AT PALACIO DEL GOBERNADOR FOR FY 2023

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Service for the Operation & Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the Ayuntamiento Building and Air Handling Units, Cooling Towers and Power Distribution Systems of BTr Offices at Palacio Del Gobernador for FY 2023, with an Approved Budget for the Contract (ABC) of Twelve Million Three Hundred Ninety Thousand Pesos (PHP12,390,000.00), inclusive of all applicable taxes;

WHEREAS, on November 25, 2022 the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 5, 2022, only one (1) prospective bidder, Renphil Trading, attended the Pre-bid Conference;

WHEREAS Renphil Trading submitted its Technical and Financial Bids, which, on December 19, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 59 - 2022 dated December 19, 2022, the BAC declared Renphil Trading as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading found the same to be responsive and thereafter, declared Commander Security Services, Inc., as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Renphil Trading., as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Service for the Operation & Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the Ayuntamiento Building and Air Handling Units, Cooling Towers and Power Distribution Systems of BTr Offices at Palacio Del Gobernador for FY 2023;
- b. recommend the award for the Supply of Service for the Operation & Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the



Ayuntamiento Building and Air Handling Units, Cooling Towers and Power Distribution Systems of BTr Offices at Palacio Del Gobernador for FY 2023 for the Contract Price of Twelve Million One Hundred Ninety Nine Thousand Six Hundred Ninety Two Pesos (PHP12,199,692.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
