DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT OF DESKTOP BUSINESS
COMPUTERS TO THE BUREAU OF THE TREASURY (BTR)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of Desktop Business Computers to the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Ten Million Nine Hundred Fifty-Eight Thousand Pesos (Php10,958,000.00), inclusive of all applicable taxes;

WHEREAS, on December 7, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 14, 2020, five (5) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) DCI International I.T. Solution and Services Corp., 3) Masangkay Computer Center, 4) Quartz Business Products Corporation, and 5) Link Network Solutions Inc. attended the Pre-bid Conference;

WHEREAS, five (5) bidders, namely, 1) Integrated Computer Systems, Inc., 2) Advance Solutions Inc., 3) DCI International I.T. Solution and Services Corp., 4) Accent Micro Technologies Inc., and 5) Quartz Business Products Corporation participated in the bidding;

WHEREAS, pursuant to Resolution No 13 - 2021 dated December 23, 2020, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc., found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

 a. declare Integrated Computer Systems, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of One (1) Lot of Desktop Business Computers to the Bureau of the Treasury (BTr);



- b. recommend the award for the Supply and Delivery of One (1) Lot of Desktop Business Computers to the Bureau of the Treasury (BTr) for the Contract Price of EIGHT MILLION SEVEN HUNDRED FORTY-FOUR THOUSAND EIGHT HUNDRED FOUR PESOS (Php8,744,804.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
