RESOLUTION NO. 83 - 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY OF SECURITY SERVICES FOR FY 2023

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Security Services for FY 2023 with an Approved Budget for the Contract (ABC) of Sixteen Million Eight Hundred and Eighty-Two Thousand Pesos (Php16,882,000.00), inclusive of all applicable taxes;

WHEREAS, on November 25, 2022 the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 5, 2022, two (2) prospective bidders, namely, 1) Commander Security Services, Inc., and 2) Tac Security Agency, Inc., attended the Pre-bid Conference

WHEREAS Commander Security Services, Inc., submitted its Technical and Financial Bids, which, on December 19, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 60 - 2022 dated December 19, 2022, the BAC declared Commander Security Services, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Commander Security Services, Inc., found the same to be responsive and thereafter, declared Commander Security Services, Inc., as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Commander Security Services, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Security Services for FY 2023;
- b. recommend the award for the Supply of Security Services for FY 2023 for the Contract Price of Sixteen Million Seven Hundred Seventy Nine Thousand Five Pesos and 28/100 (PHP16,779,005.28), inclusive of all applicable taxes; and
