DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT OF VIDEO CONFERENCE
APPLIANCE FOR THE BUREAU OF THE TREASURY (BTR)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of Video Conference Appliance for the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Two Million Pesos (Php2,000,000.00), inclusive of all applicable taxes;

WHEREAS, on May 25, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on June 2, 2021, nine (9) prospective bidders, namely, 1) American Technologies, Inc., 2) Audiophile Components, Inc., 3) Avid Sales Corporation, 4) AVLS All Visual & Lights Systems Corporation, 5) Cosmotech Philippines, Inc., 6) Imatech Corporation, 7) InfoBahn Communications, Inc., 8) The Brain Computer Corporation and 9) Trends and Technologies, Inc. attended the Prebid Conference;

WHEREAS, three (3) bidders, namely, 1) American Technologies, Inc., 2) Avid Sales Corporation, 3) Infobahn Communications, Inc. participated in the bidding;

WHEREAS, pursuant to Resolution No 36 - 2021 dated June 14, 2021, the BAC declared Infobahn Communications, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Infobahn Communications, Inc., found the same to be responsive and thereafter, declared Infobahn Communications, Inc. as the Lowest Calculated and Responsive Bidder (LCRB):

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare Infobahn Communications, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of One (1) Lot of Video Conference Appliance for the Bureau of the Treasury (BTr);





- b. recommend the award for the Supply and Delivery of One (1) Lot of Video Conference Appliance for the Bureau of the Treasury (BTr) for the Contract Price of ONE MILLION EIGHT HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS (Php1,818,888.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
