RESOLUTION NO. 120 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY OF SECURITY SERVICES FOR FY 2022**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Security Services for FY 2022 with an Approved Budget for the Contract (ABC) of Fourteen Million Four Hundred Thousand Pesos (Php14,400,000.00), inclusive of all applicable taxes;

WHEREAS, on December 15, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 22, 2021, two (2) prospective bidders, namely, 1) Lockheed Royale Security Agency, Inc. and 2) Commander Security Services, Inc. attended the Pre-bid Conference;

WHEREAS, Commander Security Services, Inc., submitted its Technical and Financial Bids, which, on December 31, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 91 - 2021 dated December 31, 2021, the BAC declared Commander Security Services, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Commander Security Services, Inc. found the same to be responsive and thereafter, declared Commander Security Services, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Commander Security Services, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Security Services for FY 2022;
- b. recommend the award for the Supply of Security Services for FY 2022 for the Contract Price of Fourteen Million Three Hundred Ninety-One Thousand Fifty-Two Pesos and 80/100 (Php14,391,052.80), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
