RESOLUTION NO. 43 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF SUPPORT AND MAINTENANCE SERVICES FOR
THE EXISTING DOCUMENT TRACKING SYSTEM OF THE BUREAU OF THE
TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Support and Maintenance Services for the existing Document Tracking System of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Nine Hundred Thousand Pesos (Php1,900,000.00), inclusive of all applicable taxes;

WHEREAS, on May 25, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on June 2, 2021, three (3) prospective bidders, namely, 1) My Creative Panda Web Design and Development Consultancy Services, 2) MyBusybee, Inc., and 3) Pinnacle Technologies, Inc. attended the Pre-bid Conference;

WHEREAS, two (2) bidders, namely, 1) Pinnacle Technologies, Inc. and 2) My Creative Panda Web Design and Development Consultancy Services participated in the bidding;

WHEREAS, pursuant to Resolution No 37 - 2021 dated June 14, 2021, the BAC declared Pinnacle Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Pinnacle Technologies, Inc., found the same to be responsive and thereafter, declared Pinnacle Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Pinnacle Technologies, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Support and Maintenance Services for the existing Document Tracking System of the Bureau of the Treasury;

- b. recommend the award for the Procurement of Support and Maintenance Services for the existing Document Tracking System of the Bureau of the Treasury for the Contract Price of ONE MILLION EIGHT HUNDRED SIXTY THOUSAND PESOS (Php1,860,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings


