## **RESOLUTION NO. 121 - 2021**

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PREVENTIVE MAINTENANCE FOR THE AUDIO VISUAL SYSTEM AT THE CAFETERIA, MARBLE HALL, OSMEÑA THEATER, AND DEALING ROOM OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, Osmeña Theater, and Dealing Room of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Seventy Thousand Pesos (Php1,070,000.00), inclusive of all applicable taxes;

WHEREAS, on December 15, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 22, 2021, two (6) prospective bidders, namely, 1) JMS Technology, and 2) AVLS All Visual and Lights Systems Corporation attended the Pre-bid Conference;

**WHEREAS,** AVLS All Visual and Lights Systems Corporation, submitted its Technical and Financial Bids, which, on December 31, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 92 - 2021 dated December 31, 2021, the BAC declared AVLS All Visual and Lights Systems Corporation as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by AVLS All Visual and Lights Systems Corporation found the same to be responsive and thereafter, declared AVLS All Visual and Lights Systems Corporation as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare AVLS All Visual and Lights Systems Corporation as the Single Calculated and Responsive Bidder (SCRB) for the Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, Osmeña Theater, and Dealing Room of the Bureau of the Treasury;



- b. recommend the award for the Preventive Maintenance for the Audio Visual System at the Cafeteria, Marble Hall, Osmeña Theater, and Dealing Room of the Bureau of the Treasury for the Contract Price of One Million Fifty Thousand Pesos (Php1,050,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
