DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE MULTI-YEAR MAINTENANCE AND SUPPORT SERVICES FOR NROSS SYSTEM (RE-BID) / ITB-18-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the the Multi-Year Maintenance and Support Services for the NRoSS System (Re-Bid) with an Approved Budget for the Contract (ABC) of One Hundred Two Million Three Hundred Eighty-Eight Thousand Four Hundred Ninety Seven Pesos (PHP102,388,497.00), inclusive of all applicable taxes;

WHEREAS, on April 20, 2023, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on April 28, 2023, only one (1) prospective bidder, the Joint Venture of Montran Corporation and Allcard Inc. attended the Pre-bid Conference;

WHEREAS, only the Joint Venture of Montran Corporation and Allcard Inc., submitted its Technical and Financial Bids on May 11, 2023;

WHEREAS, pursuant to Resolution No. 03-2023 dated May 11, 2023, the BAC declared the Joint Venture of Montran Corporation and Allcard Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by the Joint Venture of Montran Corporation and Allcard Inc. found the same to be responsive and thereafter, declared the Joint Venture of Montran Corporation and Allcard Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare the Joint Venture of Montran Corporation and Allcard Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Multi-Year Maintenance and Support Services for the NRoSS System;
- b. recommend the award for the Multi-Year Maintenance and Support Services for the NRoSS System for the Contract Price of One Hundred Two Million Three
