RESOLUTION NO. 12 - 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT FOR THE
TRUST FUND MANAGEMENT COMMITTEE (TFMC) SECRETARIAT
LOT 1 - DESKTOP**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 1 – Desktop with an Approved Budget for the Contract (ABC) of One Million Two Hundred Seventy-Four Thousand Seven Hundred Pesos (Php1,274,700.00), inclusive of all applicable taxes;

WHEREAS, on March 29, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on April 6, 2022, three (3) prospective bidders, namely, 1) DCI International I.T. Solutions & Services Corporation, 2) Infocentric Solutions Inc. and 3) Integrated Computer Systems, Inc. attended the Pre-bid Conference;

WHEREAS, DCI International I.T. Solutions & Services Corporation, submitted its Technical and Financial Bids, which, on April 19, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 05 - 2022 dated April 19, 2022, the BAC declared DCI International I.T. Solutions & Services Corporation as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by DCI International I.T. Solutions & Services Corporation found the same to be responsive and thereafter, declared DCI International I.T. Solutions & Services Corporation as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare DCI International I.T. Solutions & Services Corporation as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 1 – Desktop;

- b. recommend the award for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 1 – Desktop for the Contract Price of One Million Two Hundred Eighteen Thousand Pesos (Php1,218,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
