**RESOLUTION NO. 07-2023**

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)  
FOR THE SUPPLY, INSTALLATION, AND COMMISSIONING OF VARIOUS ICT  
EQUIPMENT FOR THE NATIONAL REGISTRY OF SCRIPLESS SECURITIES  
OF THE BUREAU OF THE TREASURY (RE-BID) / ITB-19-2023-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry Of Scripless Securities Of The Bureau Of The Treasury (Re-Bid ITB-19-2023-G) with an Approved Budget for the Contract (ABC) of Twenty Two Million Two Hundred Thousand Pesos (PHP 22,200,000.00), inclusive of all applicable taxes;

**WHEREAS**, on April 20, 2023, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on April 28, 2023, five (5) bidders, namely, 1. Integrated Computer Systems, Inc. 2. Infobahn Communications Inc. 3. Altair I Solutions, Inc. 4. Allcard Inc., and 5. Questech Co. Inc., attended the Pre-bid Conference;

**WHEREAS**, four (4) bidders, namely, 1. Integrated Computer Systems, Inc. 2. Infobahn Communications Inc. 3. Altair I Solutions, Inc., and 4. Questech Co. Inc., submitted their Technical and Financial Bids on May 11, 2023;

**WHEREAS**, pursuant to Resolution No. 04-2023 dated May 11, 2023, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry Of Scripless Securities Of The Bureau Of The Treasury;

- b. recommend the award for the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry Of Scripless Securities Of The Bureau Of The Treasury for the contract price of PESOS: Seventeen Million Nine Hundred Twenty-Eight Thousand Eight Hundred Eighteen (PHP 17,928,818.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
