**RESOLUTION NO. 47 - 2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE PROCUREMENT OF ONE (1) YEAR COMPREHENSIVE  
MAINTENANCE AND SUPPORT SERVICES FOR THE NROSS SYSTEM (RE-BID)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Year Comprehensive Maintenance and Support Services for the NRoSS System (Re-bid) with an Approved Budget for the Contract (ABC) of Thirty Million Pesos (Php30,000,000.00), inclusive of all applicable taxes;

**WHEREAS**, on August 31, 2021 the prospective bidder, the Joint Venture Montran Corporation and AllCard, Inc., attended the Pre-bid Conference;

**WHEREAS**, on September 9, 2021, Supplemental Bid Bulletin No. 05 - 2021 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by the Joint Venture of Montran Corporation and AllCard, Inc., found the same to be responsive and thereafter, declared the Joint Venture of Montran Corporation and AllCard, Inc., as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare the Joint Venture of Montran Corporation and AllCard, Inc., as Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Year Comprehensive Maintenance and Support Services for the NRoSS System (Re-bid);
- b. recommend the award for the Procurement of One (1) Year Comprehensive Maintenance and Support Services for the NRoSS System (Re-bid) for the Contract Price of Thirty Million Pesos (Php30,000,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
