## **RESOLUTION NO. 08-2023**

## DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND INSTALLATION OF ADDITIONAL MEMORY MODULES TO UPGRADE THE EXISTING SERVERS OF THE BUREAU / ITB-20-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of Additional Memory Modules to Upgrade the Existing Servers of the Bureau (ITB-20-2023-G) with an Approved Budget for the Contract (ABC) of One Million Nine Hundred Ninety-Nine Thousand Pesos (PHP1,999,000.00), inclusive of all applicable taxes;

**WHEREAS,** on April 20, 2023, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on April 28, 2023, two (2), namely; 1) Integrated Computer Systems, Inc., and 2) Questech Co. Inc., attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc., and Questech Co. Inc., submitted their Technical and Financial Bids on May 11, 2023;

WHEREAS, pursuant to Resolution No. 05-2023 dated May 11, 2023, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Installation of Additional Memory Modules to Upgrade the Existing Servers of the Bureau;
- b. recommend the award for the Supply and Installation of Additional Memory Modules to Upgrade the Existing Servers of the Bureau of the Treasury for the Contract Price of PESOS: One Million Five Hundred Ninety-Nine Thousand
