RESOLUTION NO. 48 - 2021

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE
SUPPLY AND INSTALLATION OF PATCH MANAGEMENT SOLUTION FOR THE
BUREAU OF THE TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of Patch Management Solution for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Three Million Pesos (Php3,000,000.00), inclusive of all applicable taxes;

WHEREAS, on September 29, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on October 6, 2021, during the scheduled Pre-Bidding Conference, four (4) prospective bidders, namely, CBSAC Enterprises, GOCOM Systems and Solutions Corporation, UNISON Computer Systems Inc. and NPI attended, but only GOCOM Systems and Solutions Corporation purchased the bidding documents;

WHEREAS, on October 12, 2021, Supplemental Bid Bulletin No. 06 - 2021 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 20, 2021, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Supply and Installation of Patch Management Solution for the Bureau of the Treasury;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- declare failure of bidding for the Supply and Installation of Patch Management Solution for the Bureau of the Treasury;
- recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- conduct re-bidding of this project.
