RESOLUTION NO. 17 - 2022

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY, DELIVERY AND INSTALLATION OF WORKSTATIONS AND OTHER OFFICE FURNITURE FOR THE TRUST FUND COMMITTEE (TFMC) SECRETARIAT OFFICE AT THE PALACIO DEL GOBERNADOR

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, and Installation of Workstations and other Office Furniture for the Trust Fund Committee (TFMC) Secretariat Office at the Palacio Del Gobernador with an Approved Budget for the Contract (ABC) of Two Million Five Hundred Thirty-Seven Thousand Two Hundred Twenty Pesos (Php2,537,220.00), inclusive of all applicable taxes;

WHEREAS, on March 29, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on April 6, 2022, eight (8) prospective bidders, namely, 1) Design Excellence Home and Office System Co., 2) Progress Home and Office Furnishings, 3) ACMI Office Systems Philippines, Inc., 4) Lee Designs Industries. Inc., 5) Asahi Design Centre, Inc., 6) Infinite Quality Designs Center, Inc., 7) MFT International Corporation, 8) Peniton Trading attended the Pre-bid Conference;

WHEREAS, six (6) bidders, namely, 1) Asahi Design Center, Inc., 2) Design Excellence Home and Office Systems Co., 3) Infinite Quality Designs Center, Inc., 4) Lee Designs Industries, Inc., 5) Peniton Trading, and 6) Progress Home and Office Furnishings participated in the bidding;

WHEREAS, pursuant to Resolution No 9 - 2022 dated April 19, 2022, the BAC declared Progress Home and Office Furnishings as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification:

WHEREAS, upon careful examination, validation and verification of all statements made and the legal, technical, and financial documents submitted by Progress Home and Office Furnishings: the same was declared as non-responsive for its failure to conform with the Section VI. Schedule of Requirements where the TWG found that the project title and reference number stated did not match the title and reference number of the project to bid, hence, leading to its non-compliance with the requirements contained in the bidding documents:

WHEREAS, a Notice of Post-Disqualification was issued to Progress Home and Office Furnishings on May 25, 2022, wherein no Motion for Reconsideration was filed, as a result, Peniton Trading, the second lowest calculated bidder was subjected to post-qualification:

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Peniton Trading, found the same to be responsive and thereafter, declared Peniton Trading as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

- a. declare Peniton Trading as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply, Delivery, and Installation of Workstations and other Office Furniture for the Trust Fund Committee (TFMC) Secretariat Office at the Palacio Del Gobernador;
- b. recommend the award for the Supply, Delivery, and Installation of Workstations and other Office Furniture for the Trust Fund Committee (TFMC) Secretariat Office at the Palacio Del Gobernador for the Contract Price of ONE MILLION SEVEN HUNDRED NINETY-EIGHT THOUSAND PESOS (Php1,798,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
