RESOLUTION NO. 18 - 2022

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE
BUREAU OF THE TREASURY CENTRAL OFFICE**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office with an Approved Budget for the Contract (ABC) of Two Million Three Hundred Thirty Thousand Pesos (Php2,330,000.00), inclusive of all applicable taxes;

WHEREAS, on May 12, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on May 20, 2022, three (3) prospective bidders, namely, 1) Toyota Balintawak, Inc., 2) Nissan Commonwealth, Inc. and 3) Areza Motor Sales attended the Pre-bid Conference;

WHEREAS, Nissan Commonwealth, Inc. and Areza Motor Sales submitted their Technical and Financial Bids on June 1, 2022;

WHEREAS, pursuant to Resolution No. 16 - 2022 dated June 1, 2022, the BAC declared Nissan Commonwealth, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Nissan Commonwealth, Inc. found the same to be responsive and thereafter, declared Nissan Commonwealth, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Nissan Commonwealth, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office;
- b. recommend the award for the Procurement of One (1) Unit Passenger Van for the Bureau of the Treasury Central Office for the Contract Price of One Million Seven Hundred Forty-Nine Thousand Pesos (Php1,749,000.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
