

AGREEMENT
PROCUREMENT OF ANTI-VIRUS LICENSES AND SUPPORT FOR END
POINT PROTECTION OF BTR DESKTOPS AND LAPTOPS BUREAU-WIDE

This Agreement made this 26th day of November 2021 between the **BUREAU OF THE TREASURY (BTr)** (hereinafter called the "Procuring Entity") with office address at the Ayuntamiento Building, Cabildo Street cor. A. Soriano Avenue, Intramuros, Manila, and **KONEK-IT NETWORK TECHNOLOGIES, INC.** with office address at 24/F Unit 409 Cityland Shaw Tower, Shaw Boulevard, cor. St. Francis St. Mandaluyong City respectively, (hereinafter called the "Supplier"):

WHEREAS, the Procuring Entity invited bids for the **PROCUREMENT OF ANTI-VIRUS LICENSES AND SUPPORT FOR END POINT PROTECTION OF BTR DESKTOPS AND LAPTOPS BUREAU-WIDE** and has accepted the Bid of the Supplier in the sum of One Million Four Hundred Ninety Thousand Pesos (Php1,490,000.00), inclusive of all applicable taxes, (hereinafter called "the Contract Price");

WHEREAS, the Procuring Entity has verified, validated, and ascertained all statements made and documents submitted by the Supplier to have complied with the legal, technical, and financial requirements under the bidding documents;

WHEREAS, in Resolution No. 54 - 2021 dated November 18, 2021, the BAC recommended to the Head of the Procuring Entity the award of the project to the Supplier;

WHEREAS, the Treasurer of the Philippines, as Head of the Procuring Entity, approved the recommendation of the BAC and, accordingly, issued the Notice of Award.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) Accepted Technical and Financial Proposals;
 - (b) Technical Specifications/Terms of Reference;
 - (c) Notice of Award; and
 - (d) Notice to Proceed.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and ancillary services and to remedy defects therein in conformity in all respects with the provisions of the Agreement.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and ancillary services and the remedying of defects therein, the Contract Price or such other sum as may be payable

under the provisions of the Agreement at the time and in the manner prescribed by the Agreement.

5. This Agreement shall be effective upon receipt of Notice to Proceed on DEC 08 2021 until JAN 07 2022, unless otherwise terminated upon grounds as provided in the GCC.

IN WITNESS WHEREOF, the parties hereto caused this Agreement to be executed in accordance with laws of the Republic of the Philippines on the day and year first above written.

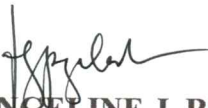
