RESOLUTION NO. 30 - 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF ONE (1) YEAR MAINTENANCE AGREEMENT AND LICENSES FOR EXISTING HYPER CONVERGED SERVER AND VIRTUALIZATION PLATFORM OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Year Maintenance Agreement and Licenses for existing Hyper Converged Server and Virtualization Platform of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Seven Hundred Thousand Pesos (Php2,700,000.00), inclusive of all applicable taxes;

WHEREAS, on August 10, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on August 18, 2022, only one (1) prospective bidder, Integrated Computer Systems, Inc. attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc., submitted its Technical and Financial Bids, which, on August 31, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 21 - 2022 dated August 31, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, following the post-qualification examination, the Technical Working Group (TWG) submitted its report to the BAC for the latter's consideration;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Year Maintenance Agreement and Licenses for existing Hyper Converged Server and Virtualization Platform of the Bureau of the Treasury;
- b. recommend the award for the Procurement of One (1) Year Maintenance Agreement and Licenses for existing Hyper Converged Server and Virtualization Platform of the Bureau of the Treasury for the Contract Price of Two Million Six Hundred Seventy-Four Thousand Nine Hundred Ninety-Nine Pesos and 98/100 (Php2,674,999.98), inclusive of all applicable taxes; and



c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
