RESOLUTION NO. 55 - 2021

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY OF LABOR AND MATERIALS FOR THE REPLACEMENT OF
TWENTY-EIGHT (28) UNITS OF CANOPY AT THE OPEN COURT OF THE
AYUNTAMIENTO**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the **Supply of Labor and Materials for the Replacement of Twenty-Eight (28) Units of Canopy at the Open Court of Ayuntamiento** with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Thousand Pesos (**Php1,700,000.00**), inclusive of all applicable taxes;

WHEREAS, on September 29, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on October 6, 2021, three (3) prospective bidders, namely, 1) MZR Builder, 2) RenPhil, and 3) Aljon International Corporation., attended the Pre-bid Conference;

WHEREAS, MZR Builders, Renphil Trading and Aljon International Corporation, submitted their Technical and Financial Bids on October 20, 2021;

WHEREAS, pursuant to Resolution No. 52 - 2021 dated October 20, 2021, the BAC declared Aljon International Corporation as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Aljon International Corporation found the same to be responsive and thereafter, declared Aljon International Corporation as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Aljon International Corporation as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply of Labor and Materials for the Replacement of Twenty-Eight (28) Units of Canopy at the Open Court of Ayuntamiento;

- b. recommend the award for the **Supply of Labor and Materials for the Replacement of Twenty-Eight (28) Units of Canopy at the Open Court of Ayuntamiento** for the Contract Price of Nine Hundred Sixty-Three Thousand Two Hundred Fourteen Pesos and 29/100 (Php963,214.29), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.


