## **RESOLUTION NO. 31 - 2022**

## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, INSTALLATION AND CONFIGURATION OF RACKMOUNT SERVERS FOR THE FIDELITY BONDING SYSTEM AND NATIONAL GOVERNMENT COLLECTION AND DISBURSEMENT SYSTEM

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Installation and Configuration of Rackmount Servers for the Fidelity Bonding System and National Government Collection and Disbursement System with an Approved Budget for the Contract (ABC) of Seven Million Two Hundred Thousand Pesos (Php7,200,000.00), inclusive of all applicable taxes;

**WHEREAS,** on August 10, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on August 18, 2022, three (3) prospective bidders, namely, 1) Equicom, Inc., 2) ePLDT, Inc., 3) Integrated Computer Systems, Inc. attended the Prebid Conference;

**WHEREAS,** Integrated Computer Systems, Inc., submitted its Technical and Financial Bids, which, on August 31, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 22 - 2022 dated August 31, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS,** following the Post-Qualification examination, the Technical Working Group (TWG) submitted its report to the BAC for the latter's consideration;

**NOW THEREFORE,** the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Installation and Configuration of Rackmount Servers for the Fidelity Bonding System and National Government Collection and Disbursement System;
- b. recommend the award for the Supply, Installation and Configuration of Rackmount Servers for the Fidelity Bonding System and National Government Collection and Disbursement System for the Contract Price of Six Million Four Hundred Sixteen Thousand Seven Hundred Forty-Four Pesos (Php6,416,744.00), inclusive of all applicable taxes; and



c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
