**RESOLUTION NO. 28 - 2022**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE  
TRUST FUND MANAGEMENT COMMITTEE SECRETARIAT**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Unit passenger Van for the Trust Fund Management Committee Secretariat with an Approved Budget for the Contract (ABC) of One Million Six Hundred Ninety Thousand Pesos (Php1,690,000.00), inclusive of all applicable taxes;

**WHEREAS**, on August 10, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on August 18, 2022, two (2) prospective bidders, namely, 1) Greensun Automotive Enterprises, Inc. and 2) Nissan Commonwealth, Inc. attended the Pre-bid Conference;

**WHEREAS**, Nissan Commonwealth, Inc. and, Greensun Automotive Enterprises, Inc., submitted their Technical and Financial Bids, which, on August 31, 2022, during the opening of the Technical Component Envelopes, Greensun Automotive Enterprises, Inc. was declared ineligible for their failure to submit the Statement of all its ongoing government and private contracts, including contracts awarded but not yet started, which is required under the Technical Documents. Therefore, only the financial bid of Nissan Commonwealth, Inc. was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 23 - 2022 dated August 31, 2022, the BAC declared Nissan Commonwealth, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Nissan Commonwealth, Inc. found the same to be in order;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Nissan Commonwealth, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Unit passenger Van for the Trust Fund Management Committee Secretariat;

- b. recommend the award for the Procurement of One (1) Unit passenger Van for the Trust Fund Management Committee Secretariat for the Contract Price of One Million Six Hundred Thirty-Eight Thousand Pesos (Php1,638,000.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
