CONTRACT AGREEMENT

THIS AGREEMENT made on the 28th day of January 2022 between **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **INFOBAHN COMMUNICATIONS, INC.** with office address at 2/F DRB (Fil-American) Bldg., 923 Aurora Blvd, Cor. La Salle St., Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs)1;
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract²; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements

Winning bidder⁵ agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of <a href="PHILIPPINE PESO: FOUR MILLION FOUR HUNDRED NINETY-FOUR THOUSAND NINE HUNDRED NINETY-SEVEN & 92/100 (PHP4,494,997.92), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, INFOBAHN COMMUNICATIONS, INC. agrees to perform and deliver the "Supply Delivery and Installation of One (1) Year License to the Existing Data Leak Prevention System for the Bureau of the Treasury" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
