**RESOLUTION NO. 62 - 2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE SUPPLY AND INSTALLATION OF ONE (1) YEAR LICENSE TO  
EXISTING BANDWIDTH MANAGER AND APPLICATION MONITORING SYSTEM  
LICENSE AND SUPPORT TO THE BUREAU OF THE TREASURY (REBID)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of One (1) Year License to Existing Bandwidth Manager and Application Monitoring System License and Support to the Bureau of the Treasury (Rebid) with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Forty-Three Thousand Eight Hundred Ninety-Three Pesos (Php1,743,893.00), inclusive of all applicable taxes

**WHEREAS**, on November 11, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on November 18, 2021, the lone bidder, Secur Links Network and Technologies, Inc. attended the Pre-bid Conference;

**WHEREAS**, Secur Links Network and Technologies, Inc., submitted its Technical and Financial Bids, which, on December 6, 2021 was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 58 - 2021 dated December 6, 2021, the BAC declared Secur Links Network and Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Secur Links Network and Technologies, Inc. found the same to be responsive and thereafter, declared Secur Links Network and Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Secur Links Network and Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Installation of One (1) Year License to Existing Bandwidth Manager and Application Monitoring System License and Support to the Bureau of the Treasury (Rebid);

- b. recommend the award for the Supply and Installation of One (1) Year License to Existing Bandwidth Manager and Application Monitoring System License and Support to the Bureau of the Treasury (Rebid) for the Contract Price of One Million Five Hundred One Thousand Thirty-Six Pesos (Php1,501,036.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.




