RESOLUTION NO. 33 - 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND DELIVERY OF VARIOUS PRINTERS FOR THE BUREAU
OF THE TREASURY (BTR) AND THE TRUST FUND MANAGEMENT
COMMITTEE (TFMC) SECRETARIAT (RE-BID)
(LOT 1 - BTR (COLORED PRINTERS))**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat (Re-bid) (LOT 1 - BTr (colored printers)) with an Approved Budget for the Contract (ABC) of One Million Seven Fifty Thousand Pesos (Php1,750,000.00), inclusive of all applicable taxes;

WHEREAS, on August 11, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on August 19, 2022, during the scheduled Pre-Bidding Conference, four (4) prospective bidders, namely, (1) Integrated Computer Systems, Inc., (2) Otus Copy Systems, Inc., (3) Gakken Philippines, Inc., and (4) Cosmic Technologies, Inc., attended the Pre-Bid Conference;

WHEREAS, Integrated Computer Systems, Inc., submitted its Technical and Financial Bids, which, on September 1, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 25 - 2022 dated September 1, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, following the Post-Qualification, the Technical Working Group (TWG) submitted its report to the BAC for the latter's consideration;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) (LOT 1 - colored printers) (Re-bid));
- b. recommend the award for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) (LOT 1 - colored printers) (Re-bid)) for the Contract

Price of One Million Five Hundred Thirteen Thousand Eight Hundred Fifty-Six Pesos and 25/100 (Php1,513,856.25), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
