RESOLUTION NO. 63 - 2021

DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY AND INSTALLATION OF A PATCH MANAGEMENT SOLUTION FOR THE BUREAU OF THE TREASURY (RE-BID)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of a Patch Management Solution for the Bureau of the Treasury (Re-bid) with an Approved Budget for the Contract (ABC) of Three Million Pesos (Php3,000,000.00), inclusive of all applicable taxes;

WHEREAS, on November 11, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on November 18, 2021, two (2) prospective bidders, namely, 1) Shellsoft Technology Corporation and 2) GOCOM Systems and Solutions Corporation attended the Pre-bid Conference;

WHEREAS, on December 6, 2021, two (2) bidders, namely, 1) Shellsoft Technology Corporation and 2) GOCOM Systems and Solutions Corporation participated in the bidding;

WHEREAS, pursuant to Resolution No 59 - 2019 dated December 6, 2021, the BAC declared Shellsoft Technology Corporation as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report, which was adopted by the BAC in a regular meeting on March 3, 2022;

WHEREAS, upon careful examination, validation and verification of all statements made and the legal, technical, and financial documents submitted by Shellsoft Technology Corporation, and found the same as non-responsive for its failure to comply with the technical specifications/ requirements as specified in the Bidding Documents and the second lowest calculated bidder was subjected to Post-Qualification;

WHEREAS, a Notice of Post-Disqualification was issued to Shellsoft Technology Corporation on March 3, 2022, wherein no Motion for Reconsideration was filed;

WHEREAS, the Technical Working Group (TWG) submitted their report upon careful examination, validation and verification of all statements made and the legal, technical, and financial documents submitted by GOCOM Systems and Solutions Corporation, and found the same as non-responsive for its failure to comply with the technical specifications/ requirements as specified in the Bidding Documents, which was adopted by the BAC in a regular meeting on March 7, 2022;

WHEREAS, a Notice of Post-Disqualification was issued to GOCOM Systems and Solutions Corporation on March 7, 2022, wherein no Motion for Reconsideration was filed;

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply and Installation of a Patch Management Solution for the Bureau of the Treasury (Re-bid) due to the bidders' failure to comply with the



technical specifications/ requirements as specified in the Bidding Documents of the bidders, and hence failed to pass the Post-Qualification;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Installation of a Patch Management Solution for the Bureau of the Treasury (Re-bid);
- b. recommend the re-bid of the Supply and Installation of a Patch Management Solution for the Bureau of the Treasury (Re-bid); and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
