## **RESOLUTION NO. 34 - 2022**

## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, INSTALLATION AND COMMISSIONING OF BACK-UP POWER SYSTEM FOR THE BUREAU OF THE TREASURY PAMPANGA OFFICE

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office with an Approved Budget for the Contract (ABC) of Two Million Five Hundred Thousand Pesos (Php2,500,000.00), inclusive of all applicable taxes;

**WHEREAS,** on August 11, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on August 19, 2022, three (3) prospective bidders, namely, 1) EGM Systems Global Technologies Inc., 2) Pointer Enterprises Inc. and 3) Renphil Trading attended the Pre-bid Conference;

WHEREAS, on September 1, 2022, Pointer Enterprises Inc. and, Renphil Trading submitted their Technical and Financial Bids, however, during the opening of the Technical Component Envelopes, Pointer Enterprises, Inc. was declared ineligible for their failure to submit the following documentary requirements: (1) Must have one (1) assigned Safety Officer and that Safety Officer must have completed training course from any accredited Safety Training Center by DOLE and a copy of that certification must be submitted; and (2) Registered Electrical Engineer showing his experience in GenSet and UPS Electrical Installation through his CV and PRC identification Card. Therefore, only the financial bid of Renphil Trading was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 27 - 2022 dated September 1, 2022, the BAC declared Renphil Trading as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading found the same to be responsive and thereafter, declared Renphil Trading as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE,** the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

a. declare Renphil Trading as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office;

- recommend the award for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office for the Contract Price of Two Million Twenty-Two Thousand Five Hundred Seventy-Eight Pesos (Php2,022,578.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
