RESOLUTION NO. 97 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND DELIVERY OF ADDITIONAL ONE (1) LOT OF LAPTOP
NOTEBOOKS TO THE BUREAU OF THE TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of additional One (1) Lot of Laptop Notebooks to the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Two Hundred Thousand Pesos (Php4,200,000.00), inclusive of all applicable taxes;

WHEREAS, on December 10, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 17, 2021, four (4) prospective bidders, namely, 1) Ablaze Marketing, 2) Advance Solutions, Inc., 3) Integrated Computer Systems, Inc. and 4) Quartz Business Products Corporation attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc., submitted its Technical and Financial Bids, which, on December 28, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 64 - 2021 dated December 28, 2021, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of additional One (1) Lot of Laptop Notebooks to the Bureau of the Treasury;
- b. recommend the award for the Supply and Delivery of additional One (1) Lot of Laptop Notebooks to the Bureau of the Treasury for the Contract Price of Three

Million Five Hundred Fifty-Five Thousand Six Hundred Pesos (Php3,555,600.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.


