DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY, INSTALLATION AND COMMISSIONING OF BACK-UP POWER SYSTEM FOR THE BUREAU OF THE TREASURY PAMPANGA OFFICE

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office with an Approved Budget for the Contract (ABC) of One Million Five Hundred Thirty-Five Thousand Pesos (Php1,535,000.00), inclusive of all applicable taxes;

WHEREAS, on December 10, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 17, 2021, only one (1) prospective bidder, Trade Venture International Corporation attended the scheduled Pre-Bidding Conference;

WHEREAS, on December 21, 2021, Supplemental Bid Bulletin No. 15 - 2021 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 28, 2021, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office;

NOW THEREFORE, the Bids and Awards Committee RESOLVED, as it hereby RESOLVES to:

- a. declare failure of bidding for the Supply, Installation and Commissioning of Back-up Power System for the Bureau of the Treasury Pampanga Office;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
