DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF SUPPORT AND MAINTENANCE SERVICES FOR THE DOCUMENT TRACKING SERVICES OF THE BUREAU OF THE TREASURY (BTR)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Support and Maintenance Services for the Document Tracking Services of the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of One Million Eight Hundred Thousand Pesos (PHP1,800,000.00), inclusive of all applicable taxes;

WHEREAS, on October 6, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on October 14, 2022, two (2) prospective bidders, namely, 1) Pinnacle Technologies, Inc., and 2) Massive Integrated Technology Solutions, Inc., attended the Pre-bid Conference;

WHEREAS, Pinnacle Technologies, Inc., submitted its Technical and Financial Bids, which, on October 26, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 39 - 2022 dated October 26, 2022, the BAC declared Pinnacle Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Pinnacle Technologies, Inc. found the same to be responsive and thereafter, declared Pinnacle Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare Pinnacle Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Support and Maintenance Services for the Document Tracking Services of the Bureau of the Treasury (BTr);

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
